\$84,151.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.

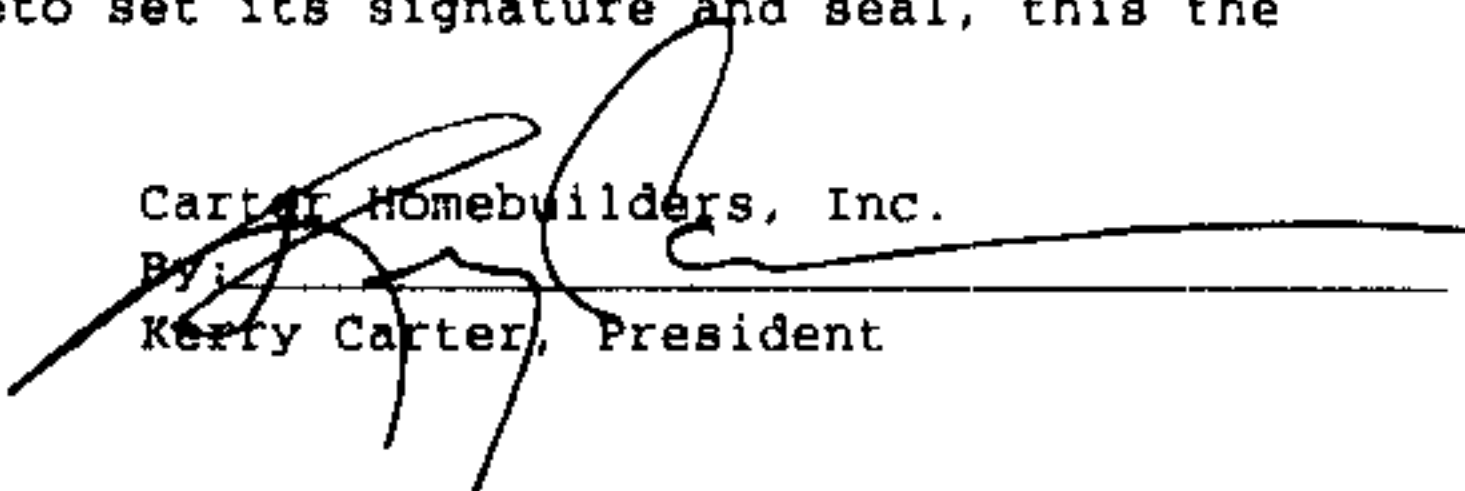

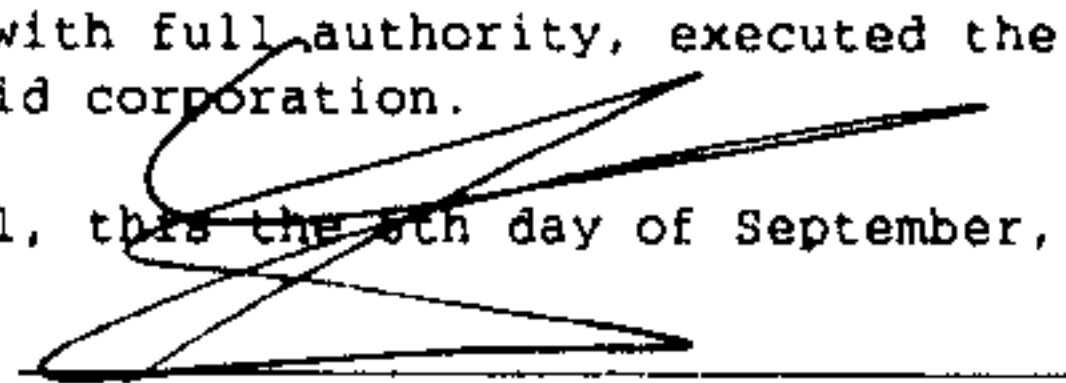
