For the purpose of further securing the payment of all of the secured indebtedness Morigagors represent, warrant, coverant and agree with Morigagos, its securests and mright, as follows:

- 1. That they are lawfully setzed in fee and possessed of the mortgaged property except as otherwise expressly stated herein, they have a good right to convey the same as aforesaid, they will warrant and forever defend the little of Morigages to the morigaged premises against the hortel claims of all persons whomsoever, and the morigaged property is free and clear of all encumbrances, casements and restrictions not hereis specifically mentioned.
- 2. That they will pay when due all taxes, assessments, and other liens or mortgages taking priority over this mortgage. That Mortgagors will indomnify and hold Mortgagoe harmiese from and against any and all loss, cost, damage, claim, liability and expense (including attorneys' feet and Higstion expenses) incurred by Morigages on account of breach by Morigagors' of any representation, warranty or covenant set forth in paragraph 11, above, or Morigagors' failure to perform any covenant or obligation under paragraph 11, or Morigagors' or the morigaged property's failure to comply fully with all environmental laws and regulations, or any other matter related to environmental conditions on, under or affecting the mortgaged property. The obligations of Mortgagors bereunder are joint and several, The provisions of this mortgage and of the note or notes secured hereby are severable, and the invalidity or unemforceability of any provision of this mortgage or of any such note or notes that not affect the validity and enforceability of the other provisions of this mortgage or of such note or notes. The remedice provided to Mortgagee herein are cumulative with the rights and remedice of Mortgages under any other agreement, at lew and in equity, and such rights and remedies may be exercised concurrently or consecutively. Time is of the smeace with respect to every covenant contained in this mortgage. This mortgage also constitutes a financing statement, and a carbon or photostatic copy of this mortgage may be filed as a financing statement in any public office.

Mortgagors hereby walve any requirement that the mortgaged property be sold in separate tracts and agree that Mortgages may, at its election, sell said property on masse regardless of the number of parcels hereby conveyed.
