



THE FORECLOSED PROPERTY

Commence at the Southwest corner of the 3/4 of the NW 1/4 of Section 2, Township 21 South, Range 3 West; run thence in an Easely direction along the South Line of said 3/4 Section for a distance of 660.05 feet to the point of beginning; from the point of beginning thus obtained; thence turn an angle to the left of 87 deg. 45 min. 12 sec. and run in a Northerly direction for a distance of 86.92 feet; thence turn an angle to the right of 15 deg. 25 min. 05 sec. and run in a Northeastly direction for a distance of 99.72 feet; thence turn an angle to the left of 32 deg. 43 min. 23 sec. and run in a Northwesterly direction for a distance of 51.42 feet; thence turn an angle to the left of 56 deg. 54 min. 17 sec. and run in a Northwestly direction for a distance of 30.93 feet; thence turn an angle to the right of 41 deg. 14 min. 32 sec. and run in a Northwesterly direction for a distance of 53.04 feet; thence turn an angle to the left of 10 deg. 51 min. 53 sec. and run in a Northwesterly direction for a distance of 137.54 feet; thence turn an angle to the right of 8 deg. 45 min. 29 sec. and run in a Northwesterly direction for a distance of 134.37 feet; thence turn an angle to the right of 41 deg. 14 min. 26 sec. and run in a Northeastly direction for a distance of 111.40 feet; thence turn an angle to the left of 72 deg. 42 min. and run in a Northwestly direction for a distance of 70.21 feet; thence turn an angle to the left of 17 deg. 24 min. 10 sec. and run in a Northwesterly direction for a distance of 65 feet; thence turn an angle to the right of 10 deg. 40 min. 09 sec. and run in a Northwesterly direction for a distance of 61.85 feet; thence turn an angle to the right of 47 deg. 51 min. 12 sec. and run in a Northwesterly direction for a distance of 60.76 feet; thence turn an angle to the right of 40 deg. 32 min. 32 sec. and run in a Northwesterly direction for a distance of 43.83 feet; thence turn an angle to the right of 64 deg. 37 min. 33 sec. and run in a Northeastly direction for a distance of 75.60 feet; thence turn an angle to the right of 19 deg. 14 min. 47 sec. and run in a Northeastly direction for a distance of 46.24 feet; thence turn an angle to the right of 20 deg. 11 min. 27 sec. and run in a Northwestly right-of-way for a distance of 213.22 feet to a point on the Southwesterly right-of-way line of B & N Railroad; thence turn an angle to the right of 105 deg. 14 min. 26 sec. to the tangent of the following described course, said course being situated on a curve to the left having a central angle of 2 deg. 09 min. 14 sec. and a radius of 1,050.06 feet; thence run along the arc of said curve to the left along the Southwesterly right-of-way line of B & N Railroad in a Southeastly direction for a distance of 73.68 feet to the end of said curve; thence run along the tangent if extended to said curve in a Southeastly direction along the Southwesterly right-of-way line of B & N Railroad for a distance of 735.23 feet to the point of beginning of a curve to the right; said curve having a central angle of 14 deg. 17 min. 06 sec. and a radius of 1,382.40 feet; thence run along the arc of said curve to the right in a Southeastly direction continuing along the Southwesterly right-of-way line of B & N Railroad for a distance of 344.66 feet to its intersection with the South Line of 3/4 of the NW 1/4 of Section 2, Township 21 South, Range 3 West; thence turn an angle to the right of 104 deg. 16 min. 09 sec. from the tangent of last described course of 104 deg. 16 min. 09 sec. and run in a Westerly direction along the South Line of said 3/4 Section for a distance of 265 feet to the point of beginning.
