I, Charles T. Anglin, hereby affirm and declare that:

(1) I am a Citizen domiciled in Alabama, within the meaning of the Constitution for the united States of America (1789), making this affirmation; and,

(2) I, Charles T. Anglin, am a natural born free white Citizen of the People of the Sovereign Body Politic in the state of Alabama by virtue of birth and inheritance and thereby a Citizen within the meaning of the Constitution for the united States of America, am of lawful age and competent to make this affirmation; and,

(3) This affirmation is made for the purpose of giving the Shelby county electors information for their records sufficient to show that the undersigned is competent to cast his vote, being that I am designated as one of the whole number of free persons at Article I, Section II, Clause 3 of the Constitution for the united States of America (1787), in the state of Alabama; and,

(4) I am a Citizen domiciled in Alabama, my temporary (?) place of abode is in the county of Shelby, in the state of Alabama and I have been living in the state of Alabama for all my natural life; and,

(5) I, Charles T. Anglin, a free white citizen of the People of the Sovereign Body Politic in the state of Alabama, was born on or about 31 May, 1951 in the county of Jefferson, in the state of Alabama, a state of the United States of America; and,

(6) I, Charles T. Anglin, was sired by Charlie Thomas Anglin, a Citizen within the meaning of the Preamble to and the Constitution for the united States of America, and thereby a member of the Sovereign Body Politic, in the state of Georgia, born on or about October 26, 1922, in the county of Troup, in the state of Georgia, a state of the united States of America; and,

(7) I, Charles T. Anglin, was given birth by Margaret G. Anglin, a free white Citizen of the Sovereign Body Politic, in the state of Alabama, born on or about September 12, 1925, in the county of Sumter, in the state of Alabama, a state of the United States of America; and,

(8) Charlie Thomas Anglin and Margaret G. Anglin were one, joined in the state of Holy wedlock at the time Charles T. Anglin was born to them; and,

(9) I hereby rescind all previous political party affiliations and any references to United States voter identification, do not wish to have any political party affiliations and/or foreign identifiers, and will not affiliate myself with any political party and/or "motor voter" or like jurisdiction in the future; and,

(10) I, Charles T. Anglin, am of lawful age and competent, am a natural born free white Citizen of the People of the Sovereign Body Politic in the state of Alabama, am without boon, benefit or statutory franchise that could cloud my natural citizenship or Unalienable Rights as a human being of the Kingdom of God; and,


(11) I, Charles T. Anglin, am of the People of the Sovereign Body Politic in the state of Alabama, thereby a Citizen as designated in the Constitution for the united States of America (1787), without implications of the 14th amendment in the United States Constitution; and,

(12) I will be casting votes in all applicable elections within the state of Alabama and the county of Shelby until I give notice to the contrary; and,

(13) The above is true and correct to the best of my knowledge and understanding and is presented in good faith; and,
