KNOW ALL MEN BY THESE PRESENTS, which are intended to constitute a Durable Power of Attorney, that I, Ricky Taylor, of Chilton County, State of Alabama, the undersigned, pursuant to Code of Alabama §26-2A-7 (1975) as amended, DO HEREBY MAKE, CONSTITUTE AND APPOINT Billy Ed Tidwell and Peggy Tidwell of Chilton County, State of Alabama, my true and lawful Attorney in Fact, for me and in my name, place and stead, and on my behalf and for my use and benefit, to do, perform and execute all and every act for the health, support, education or maintenance of the person or property of my minor child, Brandon Lee Tidwell, except the power to consent to marriage or adoption, that I may legally do through an attorney in fact, and every proper power necessary to carry out the purposes for which this power is granted, with full power of substitution and revocation, hereby ratifying and affirming that which the said Billy Ed Tidwell and Peggy Tidwell or their substitute shall lawfully do or cause to be done by themselves or their substitute lawfully designated by virtue of the power hereby conferred upon them.

The rights, powers and authority of my said Attorney in Fact herein granted shall commence upon the execution of this instrument and shall be in full force and effect upon the execution of this instrument; the authority herein conferred shall not be affected by disability, incompetency, or incapacity of said principal, Ricky Taylor; and such right, power and authority shall remain in full force and effect for a period of one (1) year.
