DURABLE POWER OF ATTORNEY

I, CLINTON DEWITT BOYER, hereinafter designated as "Principal", of Shelby County, Alabama, do hereby constitute and appoint, OBIE R. MOORE, hereinafter designated as "Attorney in Fact", of Shelby County, Alabama, as my true and lawful Attorney in Fact in and for the State of Alabama, and all other Counties and States, including foreign countries, wherein the need may arise, for the following purposes:
