Parcel I:

Lot 11, according to the Survey of Davenport's Addition to Riverchase West, Sector 1, as recorded in Map Book 8, Page 9 and 9A, in the Office of the Judge of Shelby County, Alabama.

Parcel II:

Part of the NE 1/4 of the SE 1/4 of Section 24, Township 19 South, Range 3 West, Shelby County, Alabama, being more particularly described as follows:

Beginning at the northeast corner of Lot 11, Davenport's Addition to Riverchase West, Sector 1, a map of which is recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Map Book 8, Page 9, run in a westerly direction along the north line of said Lot 11, for a distance of 118.98 feet to the northwest corner of said Lot 11; thence turn an angle to the right of 89 degrees 35' 52" and run in a northerly direction for a distance of 147.29 feet to an existing pin; thence run an angle to the right of 123 degrees 19' 48" and run in a southeasterly direction for a distance of 144.03 feet; thence turn an angle to the right of 57 degrees 48' and run in a southerly direction for a distance of 69.00 feet to the point of beginning, except any part lying in the Mountain Laurel Lane right of way.
