

**ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of the Alabama Business Corporation Act, the undersigned individual submits these Articles of Incorporation for the purpose of forming a corporation.

1. The name of the Corporation is: The Enviro-Flow Company Inc.
2. The period of the corporation's duration is perpetual.
3. The corporation is organized for profit and may engage in the transaction of any or all lawful business for which corporation may be formed in Alabama, the specific purpose of the corporation being manufacturer's representatives and sales.
4. The corporation is authorized to issue 1000 shares of no par value, common stock, with identical rights and privileges, the transfer of which is restricted according to the Bylaws of the corporation. No shares have been issued.


