KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Six Hundred Seventy Five Thousand and 00/100 Dollars (\$675,000.00) to the undersigned Grantor in hand paid by the Grantees herein, the receipt whereof is acknowledged, I, Floy B. Ogletree, an unmarried woman (herein referred to as Grantor), do grant, bargain, sell and convey unto Darrell E. Wolfley and Jann W. Wolfley (herein collectively referred to as Grantee), the following described real estate, situated in Shelby County, Alabama, to-wit:
