Commence at the Southwest corner of the Northwest Quarter of the Southeast Quarter of Section 21, Township 19 South, Range 2 West, Shelby County, Alabama; thence run in an Easterly direction along the South line of said quarter-quarter section a distance of 531 feet; thence turn an angle to the left of 92 deg. 37 min. 36 sec. and run in a Northerly direction a distance of 775.49 feet to the point of beginning; from point of beginning thus obtained thence continue along the last described course for a distance of 175.19 feet; thence turn an angle to the left of 92 deg. 38 min. 40 sec. and run in a Westerly direction for a distance of 286.78 feet to a point in the center line of a paved road; thence turn an angle of 90 deg. to the left and run in a Southerly direction along the center line of a paved road for a distance of 175 feet; thence turn an angle of 90 deg. to the left and in an Easterly direction for a distance of 278.70 feet to the point of beginning.
