# ARTICLES OF ORGANIZATION OF CAUSEY & SPAIN, L.L.C. (an Alabama Limited Liability Company)

Pursuant to the Alabama Limited Liability Company Act (the "Act"), the undersigned hereby adopt the following Limited Liability Company Articles of Organization ("these Articles"):

## **ARTICLE I**

#### **NAME**

The name of the limited liability company (the "Company") is: "Causey & Spain, L.L.C."

#### **ARTICLE II**

#### **DURATION**

The period of duration of the Company shall be 40 years from the date of the recording of these Articles with the Probate Judge of Shelby County, Alabama, unless earlier terminated by agreement of the members or by operation of law.

#### **ARTICLE III**

#### **PURPOSES**

The purpose of the Company is to acquire, own, hold for investment, and dispose of interests in real and personal property and to engage in any business and perform any act permitted by Alabama law to be engaged in or performed by limited liability companies.

# ADMISSION OF ADDITIONAL MEMBERS

No person may be admitted as an additional member without the unanimous consent of the members.

#### ARTICLE VII

# **CONTINUATION OF BUSINESS**

Upon the occurrence of an event of dissociation which terminates the continued membership of a member, the remaining members may continue the legal existence and business of the Company if (i) there are at least two remaining members or a new member is admitted, and (ii) members holding a majority of the interests in profits and capital held by the remaining members consent in writing to the continuation of the business within 90 days after the occurrence of the event of dissociation.

# **ARTICLE VIII**

# **MANAGEMENT**

The Company shall be managed by the members.

## ARTICLE IX

# **AMENDMENTS**

Any amendment to these Articles of Organization shall require unanimous approval of the members.
