WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of ONE HUNDRED NINETEEN THOUSAND NINE HUNDRED & NO/100 (\$119,900.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Phillip Seales and wife, Beverly J. Seales (herein referred to as grantors), do grant, bargain, sell and convey unto Larry M. McDevitt and wife, Natalie M. McDevitt (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

\$112,350.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.


GRANTEES' ADDRESS: 101 Pebble Drive, Alabaster, Alabama 35007.


