closed simultaneously herewith.

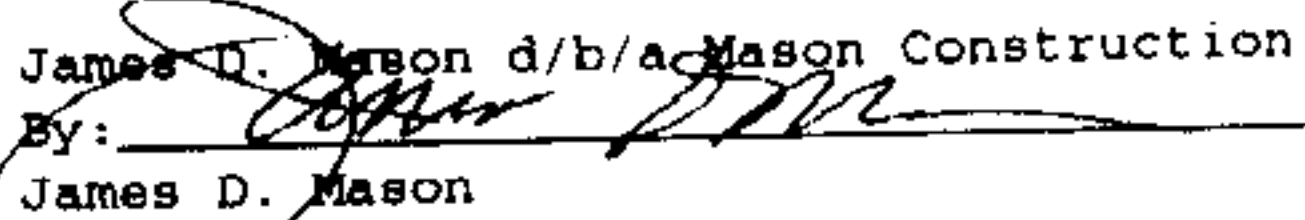

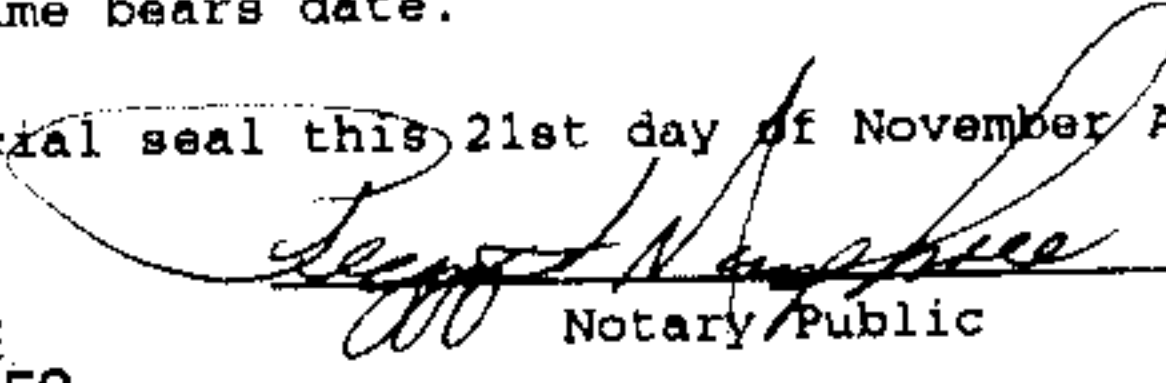
