- 14. DEFAULT. Mortgagor will be in default if any party obligated on the Secured Debt fails to make payment when due. MORTGAGE RIDER

(FORM RE-MTG-AL)

This Mortgage Rider is made this 26th day of November, 1996, and is incorporated into and shall be deemed to amend and supplement the Mortgage of the same date given by the undersigned ("Borrower" or "Mortgagor") to secure Borrower's Note to First National Bank of Shelby County ("Lender") of the same date and covering the property described in the Mortgage.

ADDITIONAL COVENANTS. In addition to or in substitution for the covenants and agreements made in the Mortgage, Borrower and Lender further covenant and agree as follows:

- 1. Property Description. The Property described in the Mortgage shall also include all personal property specifically described in the Mortgage.
