All renewal policies, with premiums paid, shall be delivered to Mortgages at least thirty (30) days before the expiration of the old policies. If any insurance, or any part thereof, shall expire,

or be withdrawn or become void or unsafe by Mortgagor's breach of any condition thereof, or become void or unsafe by reason of the teliuse or impairment of the capital of any company by which the insurance may then be carried, or if for any reason whatever the insurance shall be unsatisfactory to Mortgagee, Mortgagor shall procure and deliver to Mortgagoe new insurance on the premises, satisfactory to Mortgagoe, if Mortgagor shall not be obligated to, procure same, and upon demand, Mortgagor shall reimburse Mortgagae all such costs expended with interest on such advance at the rate set forth in the note secured hereby. Full power is haraby conferred on Mortgagoe to settle and compromise claims under all policies and to demand, receive, and receipt for all monies becoming payable therapider and to assign absolutely all policies to any holder of the note or to the grantee of the real estate in the event of the foregioeure of this mortgagoe, and security agreement or other transfer of title to the real estate in extinguishment of the indebtedness(as) secured hereby.
