- 3. Mortgagor shall keep the Mortgaged Property continuously insured in such amounts, in such manner, and with such companies as may be satisfactory to Mortgagee against loss by fire and wind(including so-called extended coverage), and other exposed hazards, including such hazards as Mortgagee may specify from time to time, with loss, if any, payable to Mortgagee under a standard mortgagee's clause providing at least 10 days notice to Mortgage of cancellation of such insurance, and shall deposit with Mortgagor policies of such insurance or, at Mortgagoe's election, certificates thereof, and shall pay the premiums therefor as the same become due.
