This Construction Mortgage Rider is made this 30th day of December, 1996, and is incorporated into and shall be deemed to amend and supplement the Mortgage of the same date given by the undersigned ("Borrower" or "Mortgagor") to secure Borrower's Note to First National Bank of Shelby County ("Lender") of the same date and covering the property described in the Mortgage.

- 1. Property Description.
