Article V

DIRECTORS

The initial board of directors will be composed of the following members:

Article VI

PURPOSES

The purpose of the Corporation is to engage in any lawful act or activity under the laws of the state of Alabama.

Article VII

DURATION

The duration of this Corporation is perpetual.

Article VIII

POWERS OF THE CORPORATION

This Corporation will have all of the powers specified in Section 10-2B-3.02 of the Alabama Business Corporation Act.

Article IX

PREEMPTIVE RIGHTS

After the first 100 shares of this Corporation are issued, each holder of the shares will have the first right to purchase additional shares of this Corporation that may be issued from time to time (including treasury shares). Each such holder of shares may purchase an amount equal to (1) the total additional shares times (2) the ratio existing between the number of shares he holds at the time of the new issue and the number of shares outstanding (exclusive of treasury shares).

This first right to purchase will be deemed waived by any Shareholder who does not exercise it, or who does not pay for the shares preempted, within 30 days of receiving written notice from the Corporation stating the prices and terms of the issue of shares and inviting him to exercise his preemptive rights.

Article X

REGULATION OF THE CORPORATION'S INTERNAL AFFAIRS

- Meetings. Meetings of the Shareholders and directors of this Corporation will be held either in or out of the State of Alabama at such place or places as may be designated in the Bylaws or by the Board of Directors.
- Bylaws. The initial Bylaws of this Corporation will be adopted by its Board of Directors. The affirmative vote of a majority of shareholders will be necessary to amend or repeal the Bylaws. The Bylaws may contain any provisions for the management of this Corporation that are consistent with the Alabama Business Corporation Act and with these Articles.
- Corporation with any person or corporation will be invalidated or affected by (1) the fact that a director of this Corporation has an interest in or is an officer of such other corporation, or (2) the fact that any director may be involved or has an interest in the contract or transaction. A person who may become a director of this Corporation is relieved of any liability arising by reason of his contracting with this Corporation for his own benefit or for the benefit of any corporation in which he may have an interest.
