RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,First Assembly of God
of the County and State aforesaid, in and for the consideration of
in hand paid by Shelby County the receipt
whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to
the public from the construction or improvement of a public road through our lands, in Shelby County,
do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-
of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public
road. Right-Of-Way herein conveyed being more particularly described as follows, to-wit:

Commence at the NE corner of the NE 1/4 of the NW 1/4 of Section 35, Township 20 South, Range 3 West; thence run Westerly along the North boundary line of said 1/4 1/4 for a distance of 1234.32 feet; thence turn an angle to the left of 54° 30' and run Southwesterly a distance of 92.85 feet; thence turn an angle to the right of 48° 10' and run Westerly a distance of 61.28 feet to the point of beginning; thence continue on the last described course a distance of 19.62 feet to the point of intersection of the South Right-Of-Way line of Whippoorwill Drive with the East Right-Of-Way line of Shelby County Road 95; thence turn an angle to the left of 89° 23' and run Southerly along the East Right-Of-Way line of County Road 95 a distance of 499.61 feet; thence turn an angle to the left of 40° 50' and run along said Right-Of-Way a distance of 103.51 feet to a point on the North Right-Of-Way line of Shelby County Road 66; thence turn an angle to the left of 43° 47' 46" and run Easterly along said Right-Of-Way a distance of 843.58 feet; thence turn an angle to the right of 90° 00' and run Southerly along said Right-Of-Way a distance of 10.0 feet; thence turn an angle to the left of 90° 00' and run Easterly along said Right-Of-Way a distance of 150 feet; thence turn an angle to the left of 90° 00' and run Northerly along said Right-Of-Way- a distance of 10 feet, thence turn an angle to the right of 90° 00' and run Easterly along said Right-Of-Way a distance of 680.05 feet; thence turn an angle to the left of 65° 51' 24" and run Northeasterly along the Eastern property line of the First Assembly of God a distance of 57.1 feet; thence turn an angle to the left of 135° 50' 55" and run Southwesterly a distance of 109.54 feet; thence turn an angle to the right of 19° 44" 24" and run Westerly a distance of 700.41 feet; thence turn an angle to the right of 09° 02' 41" and run Westerly a distance of 101.28 feet; thence turn an angle to the left of 09° 06' 26" and run Westerly a distance of 700.00 feet; thence turn an angle to the right of 14° 52' 58" and run Northwesterly a distance of 155.17 feet; thence turn an angle to the right of 69° 52' 53" and run Northerty a distance of 500.54 feet to the point of beginning. Containing 1.35 acres more or **638**.

To Have and To Hold by Shelby County, or its Assigns, and for and in consideration of the benefit to our property by reason of the construction or improvement of said road, we hereby release the County aforesaid, and all of its employees and officers, and the State of Alabama and all its employees and officers from all consequential damages, present or prospective, to our property, arising out of the construction, improvement, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged, All agreements, covering the moving, relocating and/or changing of the building and/or structures located wholly or partially on the above described right-of-way shall be in writing and approved by the State Highway Department before same shall be valid and binding on the said State Highway Department. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
