

**VERIFIED STATEMENT OF LIEN**

RICK BURCH, doing business as RICK BURCH, MARBLE CONTRACTORS, files this statement in writing, verified by the oath of RICK BURCH who has personal knowledge of the facts herein set forth:

That said RICK BURCH, MARBLE CONTRACTORS claims a lien upon the following property, situated in Shelby County, Alabama, to wit:

A parcel of land in the SW 1/4 of the SE 1/4 of Section 24, Township 19 South, Range 3 West, Shelby County, Alabama, described as follows: Commence at a 2 inch open top pipe which is the Southwest corner of said SW 1/4 of the SE 1/4 of said Section 24 and run in an Easterly direction along the South line thereof for a distance of 184.50 feet to the point of beginning, from said point of beginning, continue along the last described course for a distance of 438.49 feet; thence turn an angle to the left of 90 deg., 47 min., 46 sec. and run in a Northerly direction for a distance of 20.00 feet; thence turn an angle to the left of 58 deg., 58 min., 34 sec. and run in a Northwesterly direction for a distance of 175.72 feet; thence turn an angle to the right of 20 deg., 57 min., 41 sec. and run in a Northwesterly direction for a distance of 66.29 feet; thence turn an angle to the left of 5 deg., 47 min., 36 sec. and run in a Northwesterly direction for a distance of 30.45 feet; thence turn an angle to the left of 8 deg., 28 min., 22 sec. and run in a Northwesterly direction for a distance of 32.30 feet; thence turn an angle to the left of 82 deg., 26 min., 12 sec. and run in a Southwesterly direction for a distance of 282.03 feet to the point of beginning of the herein described parcel of land. Being situated in Shelby County, Alabama.

This lien is claimed, separately and severally, as to both the buildings and improvements thereon, and the said land.

That said lien is claimed to secure an indebtedness of four thousand seven hundred dollars and no cents (\$4,700.00), with interest, from, to wit the 10th day of January, 1997, for building material and bathroom fixtures and other building material furnished for improvements erected on the above described property.
