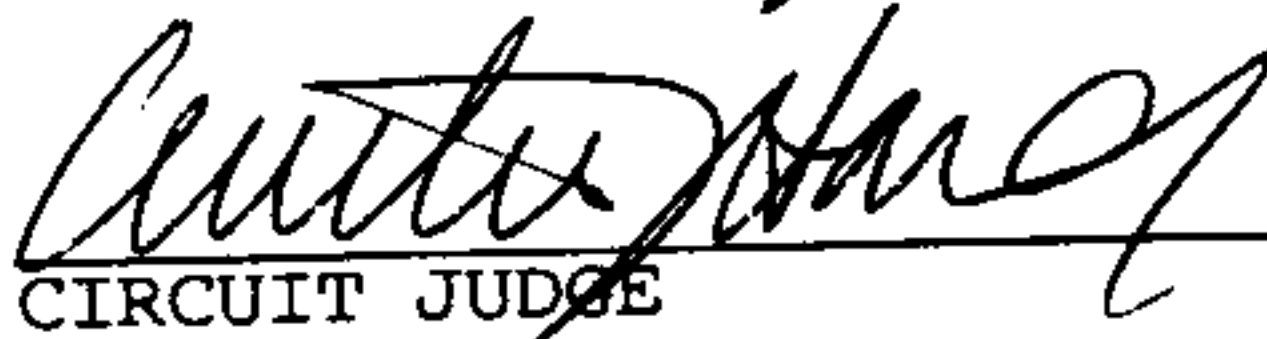

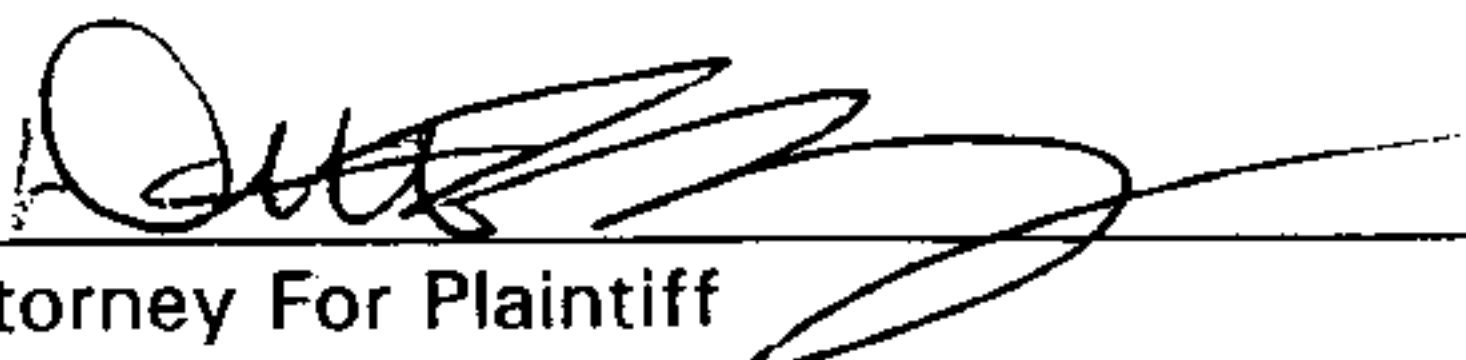

MEMORANDUM OF SETTLEMENT AGREEMENT

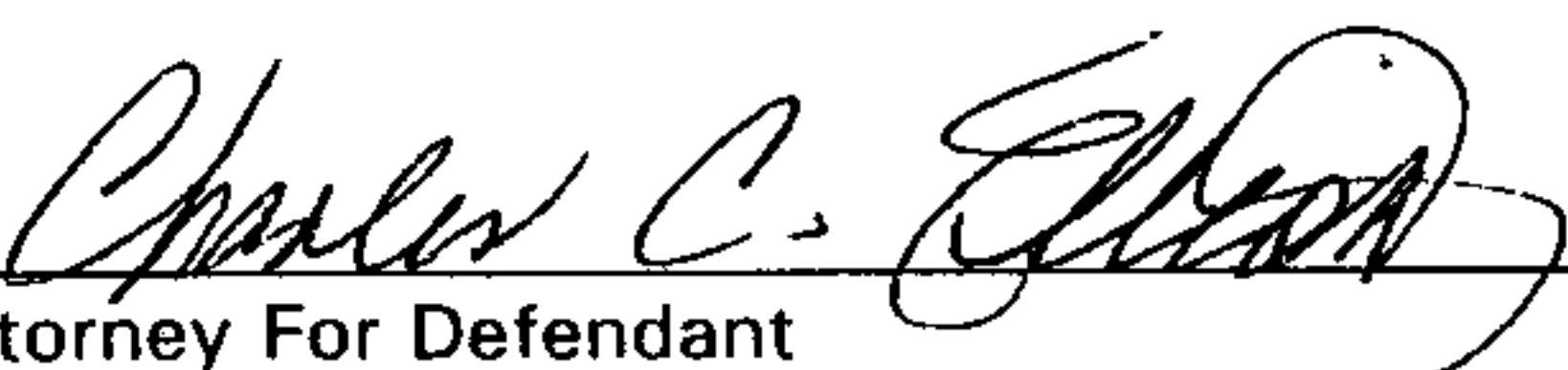
Defendant agrees to pay plaintiff the sum of thirty five thousand dollars (\$35,000.00). Defendant tenders herewith the sum of one thousand dollars (\$1,000.00) and the balance to be paid on or before December 20, 1996. Upon such payment plaintiff shall dismiss the complaint with prejudice, costs taxed as paid.

In the event defendant fails to pay plaintiff as stated above, plaintiff may, without further notice to defendant or his counsel of record, enter a consent judgment in the sum of \$ 43,228.79, said amount having been established and proven by a showing before the Hon. Art Hanes on the 30 day of September, 1996, at the call of this case to trial. In such event costs shall be taxed to defendant.
