ACKNOWLEDGEMENT OF TERMINATION OF LIFE ESTATE

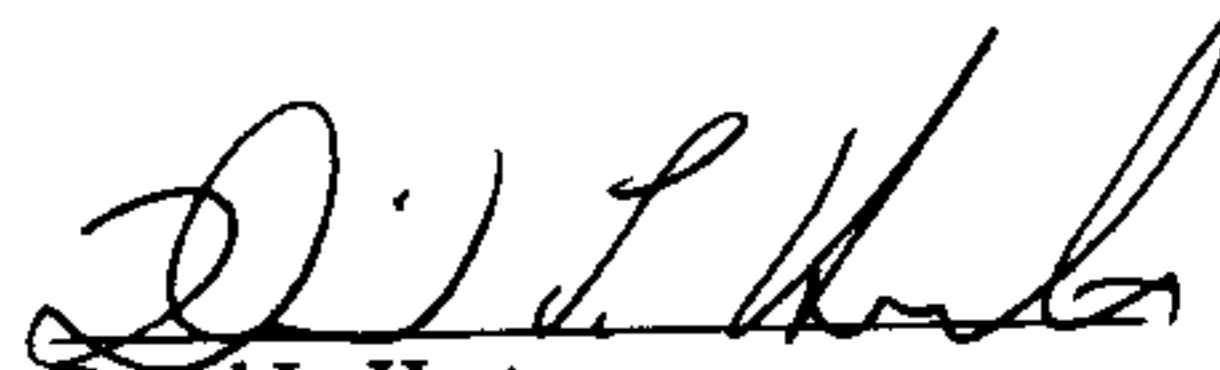
KNOW ALL MEN BY THESE PRESENTS:

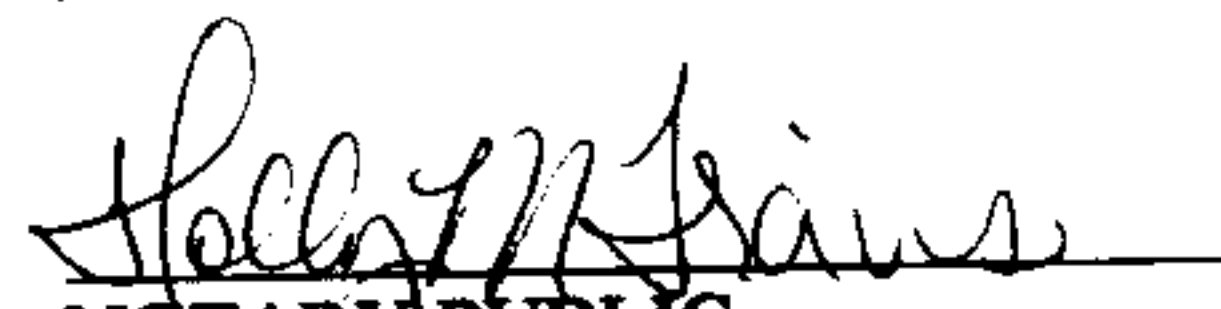
