

ARTICLES OF INCORPORATION
OF

We, the undersigned, acting as the sole incorporators under the provisions of Section 10-2B-2.02 et seq. of the 1975 Code of Alabama, as last amended on January 1, 1995, commonly known as the Alabama Business Corporation Act, hereby incorporate the hereinbelow named business corporation and hereby adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Clean Company, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is formed is the transaction of any and all lawful business for which corporations may be incorporated under Section 10-2B-3.01 and Section 10-2B-3.02 of the 1975 Code of Alabama, as last amended, and especially to engage in residential and commercial cleaning.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is ten (100) shares of One Hundred Dollars (\$1.00) par value, entitled to one vote per share.

FIFTH: The corporation shall have all the powers set forth under Section 10-2B-3.02 through Section 10-2B-3.04 of the 1975 Code of Alabama, as last amended.

SIXTH: The management of this corporation shall be vested in a Board of not less than two (2) or more than nine (9) Directors, as may be fixed by the by-laws. The Directors shall be elected at the annual meeting of the Stockholders to be held at the general office of the corporation at 3069 Lee Street, Pelham, Alabama 35124, on the Third Friday in April, each year after date at 3:00 o'clock P.m.

The number of Directors constituting the initial Board of Directors of the corporation is two (2), and the names and addresses of the persons who are to serve as Directors until the first annual meeting of

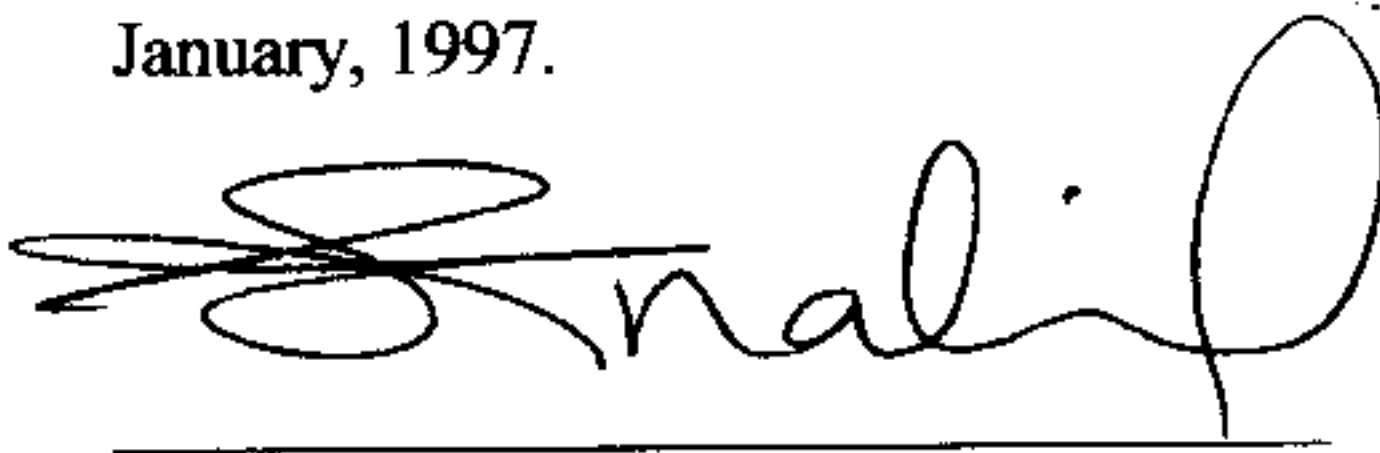

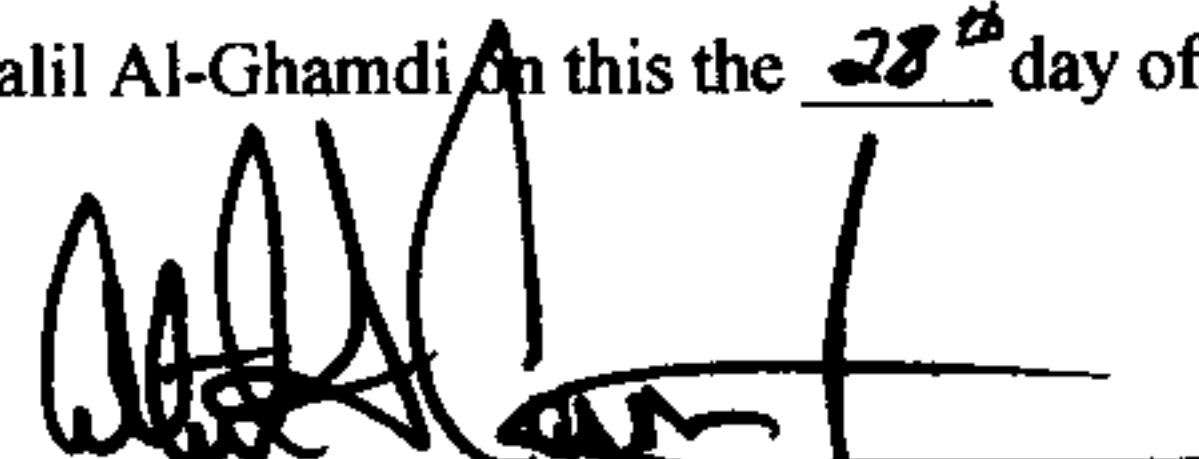
