
## Amendment to Adjustable-Rate Line of Credit Mortgage



This amendment (the "Amendment") is made and entered into on **November 27, 1996**, by and between CHARLES T. TURNER III AND WIFE. LAURA W. TURNER (hereinafter called the "Mortgagor," whether one or more) and AmSouth Bank of Alabama, (hereinafter called the "Mortgagee").

- A. Charles T. Turner III (hereinafter called the "Borrower," whether one or more) has/have entered into an Agreement entitled "AmSouth Equity Line of Credit Agreement," executed by the Borrower in favor of the Mortgagee dated October 13, 1992\*\*(the "Credit Agreement"). The Credit Agreement provides for an open-end line of credit pursuant to which the Borrower may borrow and repay, and reborrow and repay, amounts from the Mortgagee up to a maximum principal amount at any one time- outstanding not exceeding the sum of THIRTY-FOUR THOUSAND AND NO/100S Dollars (\$ 34,000.00) (the "Credit Limit").\*\*ALSO AMENDED 06-01-93
- B. The Mortgagor has executed in favor of the Mortgagee an Adjustable-Rate Line of Credit Mortgage (the "Mortgage") recorded in 1992/1993 at page 25822/20878, in the Probate Office of Shelby, County, Alabama. The Mortgage secures (among other things) all advances made by the Mortgagee to the Borrower under the Credit Agreement, or the Mortgagee to the Borrower under the Credit Agreement, or any extension or renewal thereof, up to a maximum principal amount at any one time outstanding not exceeding the Credit Limit.
- C. The Borrower and the Mortgagor have requested that the Mortgagee increase the Credit Limit to FORTY-FIVE THOUSAND AND NO/100S Dollars (\$ 45000.00) (the "Amended Credit Limit").
- D. The Mortgagee has required, as a condition to approving the request for the Amended Credit Limit, that the Mortgagor enter into this Amendment.

NOW, THEREFORE, in consideration of the premises, and in further consideration of any advances made by the Mortgagee in excess of the original Credit Limit described in the Mortgage, the Mortgagor and the Mortgagee agree that the Mortgage is, effective as of the date of this Amendment, hereby amended as follows:

- 1. The term "Credit Limit" as used in the Mortgage shall mean the Amended Credit Limit of <u>FORTY-FIVE THOUSAND AND NO/100S</u> Dollars (\$ 45000.00).
- 2. In addition to the other "Debt" described in the Mortgage, the Mortgage shall secure the payment of all advances heretofore or from time to time hereafter made by the Mortgagee to the Borrower under the Credit Agreement, or any extension or renewal thereof, up to a maximum principal amount at any one time outstanding not exceeding the Amended Credit Limit of <u>FORTY-FIVE THOUSAND AND NO/100S</u> Dollars (\$ 45000.00).

Except as specifically amended hereby, the Mortgage shall remain in full force and effect in accordance with its terms.
