#### ARTICLE FIVE

- A) The aggregate number of shares which the corporation shall have authority to issue is 100 shares of common stock at a par value of One Dollar (\$1.00) per share. Andyle Gregory Bailey will hold 100% of the shares of stock.
- B) In connection with the sale of any authorized but uninsured shares of common stock with the corporation, the Directors may by resolution deny preemptive rights to existing share holders.
- c) All shares of stock issued by the corporation shall be subject to the following restrictions on transfer, which shall be done on the certificate:
- transferred unless the holder of the restricted security offers it first to the corporation and then to any other holders of the common stock of the corporation, a prior opportunity to be exercised within a reasonable time, to acquire the restricted securities.
- 2) No shareholder may transfer any restricted security to any person or entity in competition with this corporation.
- D) Shares having a par value may be sold for such dollars as shall be fixed from time to time by the Board of Directors.

#### ARTICLE SIX

Provisions for the regulation of the internal affairs of the corporation are:

A) The majority of the shares entitled to vote, represented

in person or by proxy, shall constitute a quorum at a meeting of the shareholders. The affirmative vote of the majority of the shares represented at the meeting and entitled to vote on subject matter shall be act of the shareholders, accept that this instrument may not be amended except for the affirmative vote of the majority of the shares issued and entitled to vote thereon.

- B) The power to alter, amend or appeal the by-laws, or adopt new by-laws is vested in the Board of Directors.
- c) Upon written request of any shareholder, the corporation shall send out its most recent statement. The corporation will mail to each of the shareholders not later than 120 days after the close of its fiscal year a financial statement, including a balance sheet as of the end of such fiscal year and a statement of income for such fiscal year.

A) The initial Board of Directors of the corporation shall consist of one person, whose name and address is:
