In witness whereof, the undersigned, AmSouth Bank of Alabama, has caused these presents to be executed this 18th day of February, 1997.

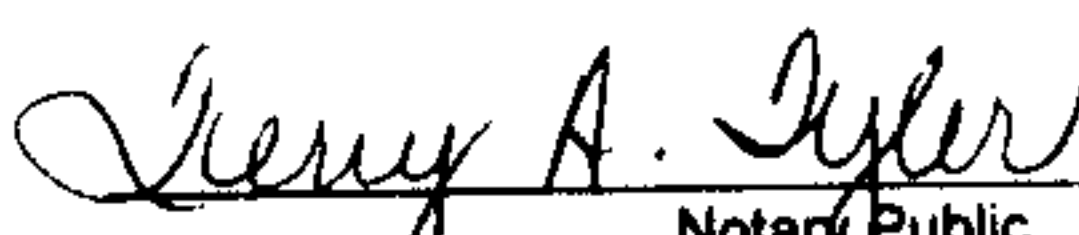
