BALL AND WIFE, ARLENE BALL**, (herein referred to as Grantors) do grant, bargain, sell and convey unto **RICHARD K. RENEW AND RENEE M. Subject to existing easements, restrictions, set back lines, rights of ways, limitations, if any, of record.

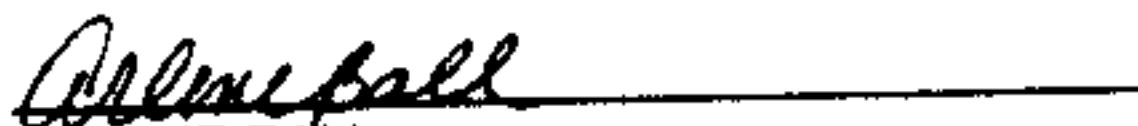
\$104,850.00 of the purchase price recited above was paid from a mortgage loan closed simultaneously herewith.

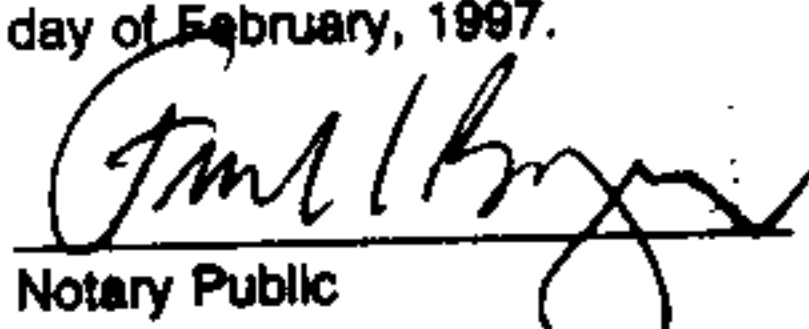
