KNOW ALL MEN BY THESE PRESENTS,

That in consideration of ONE HUNDRED ELEVEN THOUSAND FOUR HUNDRED & NO/100---- (\$111,400.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, James D. Mason d/b/a Mason Construction (herein referred to as grantors), do grant, bargain, sell and convey unto Timothy W. Pietrzykowski and wife, Jana L.
