

ARTICLES OF INCORPORATION

OF

ABERDEEN CONSTRUCTION, INC.

1. The name of the corporation is Aberdeen Construction, Inc.
2. The period of its duration is perpetual.
3. The purpose or purposes for which the corporation is organized are to engage in the general development of land, including the purchase and sale of real estate, improved and unimproved, to subdivide land into subdivisions or lots, to loan money on real property and to accept secured and unsecured notes as to collateral for the property; and to engage in any lawful act or activity for which a corporation may be organized under the Alabama Business Corporations Act.
4. The aggregate number of shares of capital stock which the corporation shall have the authority to issue is 1000 shares of common stock, par value of \$1.00 per share.
5. The location and mailing address of the initial registered office of the corporation is Highway 51, Chelsea, Alabama 35043 and the name of its initial registered agent at this address is Jackie Williams.
6. The number of directors constituting the initial board of directors of the corporation is 2, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders and until their successors are elected and shall qualify are as follows:
