Not later then the first day following the expiration date of any and all such insurance policies and at any time upon request of Mortgages. Mortgager shall furnish Mortgages certificates of insurance issued by insurance companies satisfactory to Mortgages showing that the amount and type of insurance required by Mortgages hereunder is in effect. All renewal policies, with premiums paid, shall be delivered to Mortgagee at least thirty (30) days before the expiration of the old policies. If any insurance, or any part thereof, shall expire,

be withdrawn or become void or unsafe by Mortgagor's breach of any condition thereof, or become void or unsafe by resean of the failure or bairment of the capital of any company by which the insurance may then be carried, or if for any reason whatever the insurance shall be satisfactory to Mortgages, Mortgagor shall produce and deliver to Mortgages new insurance on the premises, satisfactory to Mortgagor shall produce and deliver such new insurance, Mortgages may, but shall not be obligated to, produce same, and upon demand, Mortgagor shall give mbursa Mortgages all such costs expended with interest on such advance at the rate set forth in the note secured hereby. - 20. That Mortgagor agrees to faithfully perform all the covenants of the lessor or landlord under present and future lesses affecting the mortgaged real estate, and neither do nor neglect, nor permit to be done, anything which may diminish or impair their value, or the rents provided for therein, or the interest of the lessor or of the Mortgages therein or thereunder.
- 21. That Mortgagor shall furnish to Mortgagee within

That if the indebtedness evidenced by the note specifically referred to hereinabove is being advanced by Mortgagee to Mortgagor under the terms and provisions and in accordance with a loan agreement or construction loan agreement ("agreement"), the terms and provisions of said agreement are hereby incorporated by reference as part of this mortgage as if fully set out herein, and any default in the performance of the provisions thereof, or sny contract or agreement between Mortgagor and Mortgagee, shall constitute a default hereunder entitling Mortgagee to exercise the remedies provided herein, including the right to foreclose this mortgage in accordance with the terms hereof; that each FUTURE ADVANCE advanced by Mortgagee to Mortgagor is being advanced in accordance with an agreement dated Max. 12, 1997 and is secured by this mortgage.
- 23. That in the event this mortgage is second and subordinate to any prior mortgage(s) and in the event the Mortgagor should fail to make any payments which become due on said prior mortgage(s), or should default in any of the other terms, provisions and conditions of said prior mortgage(s) ocdur, then such default under the prior mortgage(s) shall constitute an event of default under the terms and provisions of this mortgage, and the Mortgagee herein may, at its option, declare the entire indebtedness(es) secured by this mortgage immediately due and payable and if payment is not promptly made, then declare this mortgage in default and subject to foreclosure, provided that the Mortgagee herein may, at its option, make, on behalf of Mortgagor, any such payments which become due on said prior mortgage(s), or incur any such expense or obligations on behalf of Mortgagor, in connection with the said prior mortgage(s), in order to prevent the foreclosure of said prior mortgage(s), and all such amounts so expended by the within Mortgagee on behalf of said Mortgagor shall become a debt to the Mortgagee and shall be secured by this mortgage and shall bear interest from the date of payment at the maximum legal rate of interest from time to time permitted by the laws of the State of Alabama, and shall be at once due and payable, entitling the Mortgagee to all of the rights and remedies provided herein, including, at Mortgagee's option, the right to foreclose this mortgage.

That any promise made by Mortgagor herein to pay money may be enforced by a suit at law, and the security of this mortgage shall not be walved thereby, and as to such debts the Mortgagor waives all rights of exemption under the laws and Constitution of the State of Alabama and agrees to pay as permitted by law a reasonable attorney's fee for the collection thereof.
- 26.
