MEMORANDUM OF
ANTENNA SITE LEASE SCHEDULE

This Memorandum of Antenna Site Lease Schedule is entered into on this 12TH day of March, 1997, by and between Pinnacle Towers Inc., a Florida corporation, (hereinafter referred to as "Lessor") and Sprint Spectrum L.P., a Delaware limited partnership, (hereinafter referred to as "Lessee").

1. Lessor and Lessee entered into an Antenna Site Lease Schedule ("Agreement") on the 1st day of March, 1997, for the purpose of installing, operating and maintaining a radio communications facility and other improvements, all as set forth in the Agreement.
2. The term of the Agreement is for one (1) year commencing on March 1, 1997 and ending on February 28, 1998, with five (5) successive one (1) year options to renew. If all options to renew are exercised, the term of this Agreement will expire six (6) years after the Commencement Date (as defined in the Agreement).
3. The property which is the subject of the Agreement is described in Exhibit A annexed hereto, and initialed by the parties for identification herewith.
