This Amendment to Mortgage entered into this 14th day of March, 1997, on behalf of David H. Dorough and Pamela B. Dorough (the "Mortgagors") in favor of National Bank of Commerce of Birmingham (the "Bank").

A. By Real Estate Mortgage recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. #1996/28963, the Mortgagors granted a mortgage to the Bank to secure indebtedness in the original principal amount of \$73,000.00 (the "Mortgage").

B. The Mortgagors has requested the Bank to extend further credit to the Mortgagors, and the Bank has agreed to extend further credit to the Mortgagors on the condition, among others, that the Mortgagors execute and deliver this Amendment to Mortgage.

C. This is a FUTURE ADVANCED MORTGAGE, and the credit is to be advanced by the Bank to the Mortgagors in installments from time to time pursuant to the terms and conditions of the promissory note described below.

1. WHEREAS, David H. Dorough, Pamela B. Dorough and co-signer Samuel E. Arnold, Sr. is or will be justly indebted to the Mortgagee in the amount of One Hundred Twenty Eight Thousand and no/100----\$128,000.00) as evidenced by that certain promissory note dated March 14, 1997 and which has a final maturity date of June 15, 1997.


2. Except as herein modified, the Mortgage shall remain in full force and effect.
