NOW, THEREFORE, in consideration of the mutual benefits to flow to each of the parties hereto, the undersigned hereby agree and covenant as follows, viz:

- 1. The Borrower agrees to pay the Indebtedness secured by the Mortgage in accordance with the following loan plan of FNBSC.
- (a) The credit limit is lowered from \$20,000.00 to \$18,000.00.
 - 2. The Mortgage will secure the advance as a valid first
