CAMPS and JULI M. CAMPS (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:

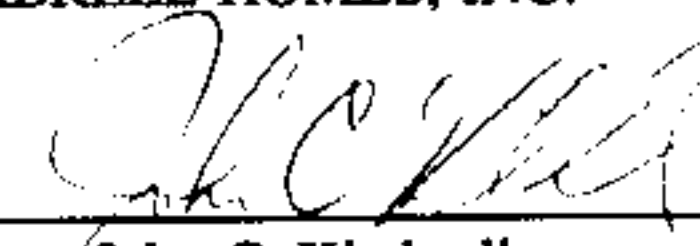
\$ 238,750.00 of the consideration was paid from the proceeds of a mortgage loan closed simultaneously herewith.
