KNOW ALL MEN BY THESE PRESENTS,

That in consideration of EIGHTY THOUSAND AND NO/100 DOLLARS (\$80,000.00), to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **William G. Veitch and wife, Janet B. Veitch**, (herein referred to as Grantors) do grant, bargain, sell and convey unto **Ronald A. Stunda and Sylvia Stunda** (herein referred to as Grantees), as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:
