- The Mortgagors shall comply and cause the real property secured by the Mortgage, as amended (the "Property"), to comply with all ap-3. plicable environmental laws and will not use the Property in a manner that will result in the disposal or any other release of any substance or material as may be defined as a hazardous or toxic substance (all such substances hereafter called "Hazardous Substances") under any applicable federal. state or local environmental law, ordinance, order, rule or regulation (collectively, the "Environmental Laws") on or to the Properly. The Mortgagors covenant and agree to keep or cause the Property to be kept free of any Hazardous Substances. In response to the presence of any Hazardous Substances under or about the Property, the Mortgagors shall immediately take, at the Mortgagors' sole expense, all remedial action required by any applicable Environmental Laws or any judgment, decree, settlement or compromise in respect to any claims thereunder. The Mortgagors shall immediately notify the Mortgages in writing of the discovery of any Hazardous Substances on, under or about the Property or any claims in connection with the Property regarding Hazardous Substances or hazardous conditions arising from Hazardous Substances.
- The Mortgagors hereby agree to defend, indemnify and hold the Mortgages and its directors, officers, agents and employees harmless. from and against all claims, demands, causes of action, liabilities, losses, costs and expenses (including without limitation reasonable aftomays) lees) arising from or in connection with any releases or discharges of any Hazardous Substances on, in or under the Property, including without limitstion remedial investigation and feasibility study costs, clean-up costs and other response costs incurred by the Mortgagee under the Environmental Laws. The obligations and liabilities of the Mortgagors under this paragraph shall survive the foreclosure of the Mortgage, as amended, or the delivery of a deed in lieu of foreclosure thereof.
- If the Property is a condominium or a planned unit development, the Mortgagors shall comply with all of the Mortgagors' obligations 5. under the declaration of covenants, the bylaws and the regulations governing the condominium or planned unit development.
- The Mortgage is amended to provide that the Mortgage shall continue in full force and effect until (i) the Mortgagors shall have fully 6. paid the indebtedness thereby secured; (ii) the Mortgagors shall have fully performed all obligations imposed on them under the Agreement, as amended; and (iii) the Mortgagee actually receives, at the address shown on the Mortgagors' monthly statement issued in connection with the Agreement, a written request to satisfy the Mortgage from the Mortgagors and all other persons who have the right to require the Mortgagee to extend advances. under the Agreement.
