Recitals

A. The Secured Line of Credit. Douglas M Melton and Kimberly S Melton (hereinafter call the "Borrower," whether one or more) is/are now or may become in the future justly indebted to the Mortgagee in the maximum principal amount of TWENTY THOUSAND AND 00/100**** Dollars (\$20000.00) (the "Credit Limit") pursuant to a certain open-end line of credit established by the Mortgagee for the borrower under an agreement (the "Credit Agreement"), entitled

The Credit Agreement provides for an open-end line of credit pursuant to which the Borrower may borrow and repay, and repay and repay, amounts from the Mortgagee up to a maximum principal amount at any one time outstanding not exceeding the Credit Limit.

- B. Rate and Payment Changes. The Credit Agreement provides for finance charges to be computed on the unpaid balance outstanding from time to time under the Credit Agreement at an adjustable ANNUAL PERCENTAGE RATE. The annual percentage rate may be increased or decreased on the first day of each billing cycle based on changes in the "Prime Rate" as published in the Wall Street Journal. The ANNUAL PERCENTAGE RATE charged under the Credit Agreement during each billing cycle will be 1.500% above the Prime Rate in effect on the first day of that billing cycle. The annual percentage rate on the date of this mortgage is 9.750%. This mortgage secures open-end or revolving indebtedness with an interest in residential property. therefore, under \$40-22-2(1)b, Code of Alabama 1975, as amended, the mortgage filing privilege tax shall not exceed \$15 for each \$100, or fraction thereof, of the Credit Limit of \$20000.00, which is the maximum principal indebtedness, to be secured by this mortgage at any one time. To have and to hold the Real Estate unto the Mortgagee, its successors and assigns forever.
