KNOW ALL MEN BY THESE PRESENTS, That in consideration of TWO HUNDRED SIXTY-FIVE THOUSAND THREE HUNDRED SEVENTY-FIVE DOLLARS AND NO/100'S DOLLARS (\$265,375.00) to the undersigned grantor, VISTA HOMES, INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto BRIAN M. ASKELSON and DENISE ASKELSON (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:
