**RELEASE**

KNOW ALL MEN BY THESE PRESENTS, That DeMarco Concrete Block Company, Inc. has a sheriff's deed on property located in Shelby County, Alabama (see copy of legal description attached hereto as Exhibit A) (herein: "the Lien").

WHEREAS, Steve Chambers, Joe Harrell and Rose Mary Chambers are the assignees of a Mortgage currently held on the subject property by Brook Line, an Alabama general partnership, to Service Corporation of Alabama, an Alabama corporation, dated August 19, 1982 and recorded in Real Volume 422, Page 727 in the Office of the Judge of Probate, Jefferson County, Alabama (herein: "Assignees").

WHEREAS, I have been asked by Assignees to release the Lien based on the following facts. I, the undersigned, Joseph A. DeMarco, Jr., personally guaranteed all indebtedness of DeMarco Concrete Block Company, Inc. and, upon the corporation's dismissal from bankruptcy, I assumed all outstanding indebtedness owed to First Alabama Bank. First Alabama Bank had a security interest in all of the assets of the corporation. Upon paying First Alabama Bank completely in full, the trustee filed a notice to abandon all property of the corporation to Joseph A. DeMarco, Jr. which included all rolling stock, account receivables, etc. Likewise, First Alabama Bank assigned all their rights in their security and financial agreement to me in consideration of my payment of all of the such indebtedness. Consequently, the undersigned received all the abandoned assets of the corporation and, since that time, has routinely executed releases for debts of the corporation.

WHEREAS, for the consideration set forth below, I, Joseph A. DeMarco, Jr., agrees to release such Lien.

NOW, THEREFORE, the undersigned acknowledges receipt of Ten and no/100 Dollars (\$10.00) as full payment of such release and satisfaction as successor in interest to the assets of DeMarco Concrete Block Company, Inc.

IN WITNESS WHEREOF, In consideration of such payment, the undersigned hereby releases the above-described property from the lien of said instrument executed this the 19th day of March, 1997.

Begin at the Southwest corner of Section 22, Township 20 South, Range 3 West, Shelby County, Alabama; thence deflect 134 degrees 40 minutes 46 seconds to the left from the South line of said Section 22 and run in a Northwesterly direction a distance of 502.68 feet to a point, thence turn an interior angle of 103 degrees 23 minutes 41 seconds and run to the right in a Northeasterly direction a distance of 523.68 feet to a point; thence turn an interior angle of 90 degrees 53 minutes 03 seconds and run to the right in a Southeasterly direction a distance of 60.00 feet to the PC of a curve to the right; thence turn an interior angle of 176 degrees 24 minutes 46 seconds to the tangent of said curve to the right having a central angle of 31 degrees 00 minutes 00 seconds and a radius of 478.97 and run in a Southeasterly direction along the arc of said curve a distance of 229.15 feet to a point; thence turn an interior angle of 282 degrees 00 minutes 00 seconds from the tangent of said curve to the right and run to the left in a northeasterly direction a distance of 100.00 feet to a point; thence turn an interior angle of 140 degrees 30 minutes 00 seconds and run to the right in a Easterly direction a distance of 548.00 feet to a point; thence turn an interior angle of 86 degrees 40 minutes 30 seconds and run to the right in a Southerly direction a distance of 88.65 feet to a point; thence turn an interior angle of 171 degrees 13 minutes 27 seconds and run to the right in a Southwesterly direction a distance of 154.14 feet to a point; thence turn an interior angle of 168 degrees 28 minutes 50 seconds and run to the right in a Southwesterly direction a distance of 181.10 feet to a point ; thence turn an interior angle of 182 degrees 25 minutes 30 seconds and run to the left in a Southwesterly direction a distance of 264.64 feet to a point on the South line of said Section 22; thence turn an interior angle of 110 degrees 35 minutes 34 seconds and run to the right in a Westerly direction along the South line of said Section 22 a distance of 575.59 feet to the point of beginning.
