KNOW ALL MEN BY THESE PRESENTS,

That in consideration of ONE HUNDRED THREE THOUSAND ONE HUNDRED & NO/100-- (\$103,100.00) DOLLARS to the undersigned grantor or grantors in hand paid the GRANTEES herein, the receipt whereof is acknowledged, James D. Mason d/b/a Mason Construction (herein referred to as grantors), do grant, bargain, sell and convey unto Scott M. Madere and wife, Tricia J. Madere (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:
