**ARTICLES OF ORGANIZATION**  
**OF**

The undersigned, being all the members of Cahaba River Investment Company, L.L.C., a limited liability company formed pursuant to Section 10-12-1 et. seq. of the Alabama Code, adopt the following Articles of Organization for such company:

**FIRST:** The name of the company is Cahaba River Investment Company, L.L.C.

**SECOND:** The term of the company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue for a period of forty (40) years thereafter; provided, however, that the company shall be dissolved prior to such date (a) upon the written consent of the holders of the portion of the ownership interest of the company specified in the Operating Agreement, as amended from time to time, (b) as provided in the Operating Agreement, as amended from time to time, or (c) as may be required by the Alabama Limited Liability Company Act.

**THIRD:** The purpose or purposes for which the Company is organized are (i) to acquire or invest in, hold, sell or otherwise dispose of, develop, operate, manage and/or mortgage properties and assets of every kind and nature, whether real or personal, tangible or intangible, (ii) to engage in the transaction of any lawful business permitted under the laws of the State of Alabama, (iii) to borrow money and to evidence the same by notes or other evidences of indebtedness and to secure the same by mortgage, deed of trust, pledge or other lien or security interest in furtherance of any or all of the purposes of the Company, (iv) to enter into, perform and carry out contracts and agreements necessary, appropriate or incidental to the accomplishment of the purposes of the Company; and (v) to do any other acts and things which may be necessary, appropriate or incidental to the carrying out of the business and purposes of the Company, subject to the terms and conditions of this Operating Agreement.

**FOURTH:** The names and address of the initial members of the Company are as follows:

**FIFTH:** The address of the initial registered office of the Company is 3125 Harwick Drive, Birmingham, AL 35242 and the name of its initial registered agent at such address is J. Steven Bookout.

**SIXTH:** The Company shall be managed by its members.

**SEVENTH:** The members shall have no right to admit additional members, except in accordance with the Operating Agreement, as amended from time to time.

**EIGHTH:** The remaining members of the Company shall have the right to continue the Company after the occurrence of an event of dissociation terminates the membership of a member as and to the extent provided in the Operating Agreement, as amended from time to time.
