KNOW ALL MEN BY THESE PRESENTS, That in consideration of **TWO HUNDRED EIGHTY-SIX THOUSAND FOUR HUNDRED FIFTY DOLLARS AND NO/100'S DOLLARS (\$286,450.00)** to the undersigned grantor, **BENSON CUSTOM HOMES, INC.**, a corporation, (herein referred to as **GRANTOR**), in hand paid by the **GRANTEES** herein, the receipt of whereof is acknowledged, the said **GRANTOR** does by these presents grant, bargain, sell, and convey unto **FRANK J. TORTORICI** and **CHRIS C. TORTORICI** (herein referred to as **GRANTEES**) as joint tenants, with right of survivorship, the following described real estate, situated in **SHELBY** County, Alabama:


\$214,600.00 of the consideration was paid from the proceeds of a mortgage loan closed simultaneously herewith.
