Amendment to Adjustable-Rate Line of Credit Mortgage

This amendment (the "Amendment") is made and entered into on <u>April 26, 1997</u>, by and between <u>JAMES M. TIMMERMAN JR. AND WIFE M. LYNN TIMMERMAN</u> (hereinafter called the "Mortgagor," whether one or more) and AmSouth Bank of Alabama, (hereinafter called the "Mortgagee").

Except as specifically amended hereby, the Mortgage shall remain in full force and effect in accordance with its terms.
