acknowledged, and the further sum of N/A DOLLARS,
to be paid to N/A by said N/A as follows, to-wit:

do grant, bargain, sell and convey unto said AFP his agent, employees,
and assigns, all trees regardless of size and species now standing and growing upon the following described lands, situated in
the County of Shelby and State of Alabama, to-wit:

All merchantable trees on the property described as:
Beginning at a point on the East line of the NW 1/4, SW 1/4, Sec 19, T22S, R3W,
Shelby Co., Alabama, 1003.55 ft North of the Southeast corner of said 1/4, 1/4
section, go left at an angle of 84 degrees 04 minutes 315.73 feet; thence left
5 degrees 56 minutes 291.84 feet; thence right 90 degrees 06 minutes 606.58 feet;
thence right 76 degrees 54 minutes 469.58 feet; thence right 55 degrees 53 minutes
345.78 feet; thence right 18 degrees 58 minutes 276.58 feet; thence right 67
degrees 59 minutes 345.34 feet/ thence right 43 degrees 18 minutes 16.26 feet to
the point of beginning. Being 11 acres more or less.

one years from the date hereof within which to cut and remove said timber herein conveyed.

the said AFP's heirs, assigns, and successors, that I lawfully
seized in fee simple of the property herein conveyed; that it is free from all incumbrance, and that I have a good
right to sell and convey the said property; that I will and my heirs, executors, and administrators shall
warrant and defend the same to the said AFP heirs, assigns, and successors,
forever, against the lawful claims of all persons whatsoever.
