IT IS UNDERSTOOD AND AGREED THAT SHOULD THE COUNTY OF SHELBY REQUIRE A 60 FOOT RIGHT OF WAY, THE PARTIES HERETO AGREE TO GRANT SUCH ADDITIONAL PROPERTY NECESSARY TO WIDEN THE RIGHT OF WAY EASEMENT OF 60 FEET.

THE RIGHT OF WAY EASEMENT HAS NOT BEEN DEFINITELY DESCRIBED ON THIS DATE; HOWEVER, THE GRANTOR RESERVES THE RIGHT TO RELOCATE THE ROAD FROM ITS PRESENT LOCATION, SO LONG AS IT ADQUATELY SERVES THE GRANTEE'S NECESSARY ACCESS.

THE GRANTOR HEREBY RESERVES THE RIGHT TO USE SAID RIGHT OF WAY EASEMENT FOR HIS PURPOSES.

THE GRANT AND OTHER PROVISIONS OF THIS RIGHT OF WAY EASEMENT SHALL CONSTITUTE A COVENANT RUNNING WITH THE LAND FOR THE BENEFIT OF THE GRANTEE AND THE GRANTOR, AND THEIR HEIRS, SUCCESSORS AND ASSIGNS.
