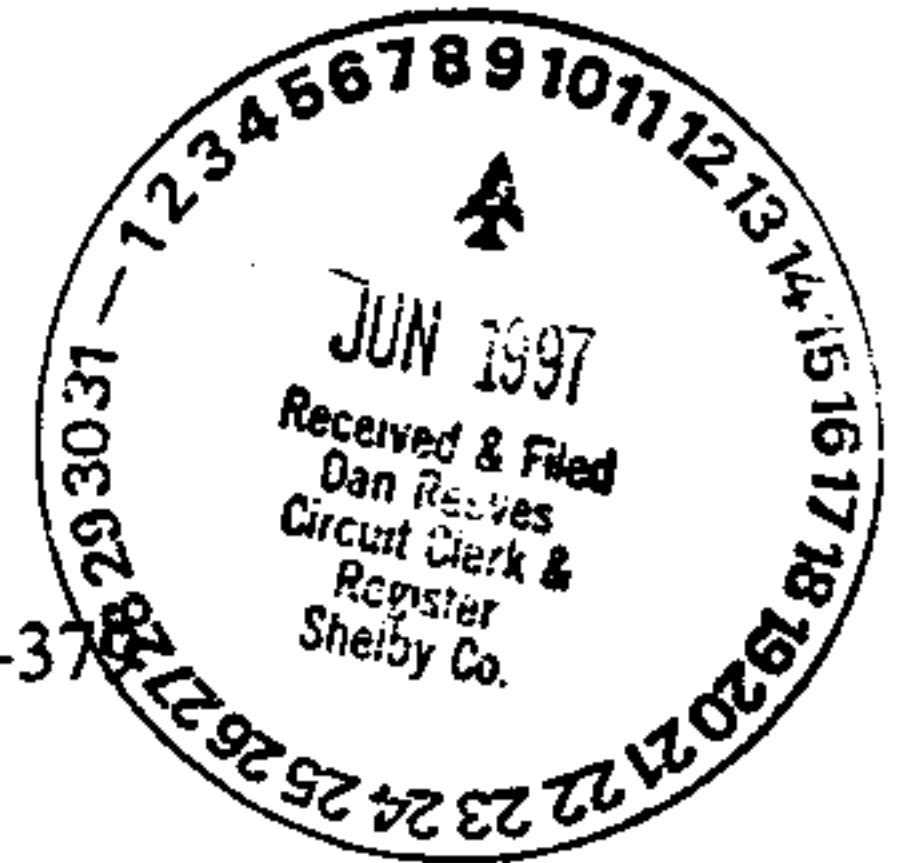

ORDER

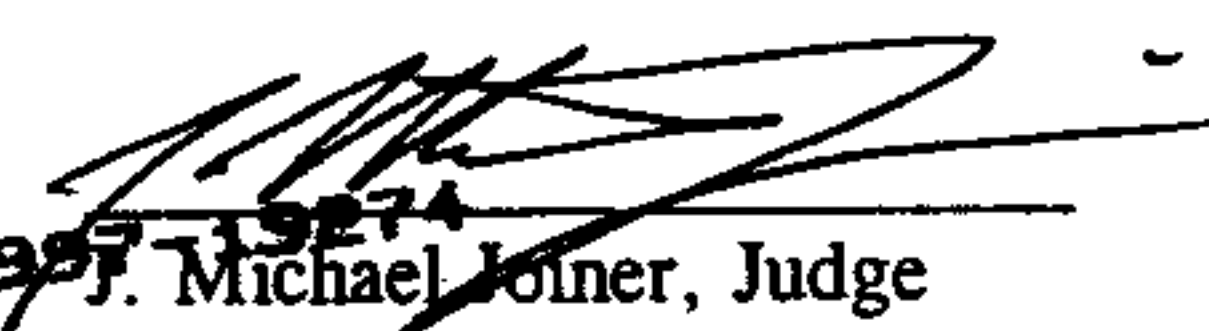
