(herein referred to as Grantee, whether one or more), in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Lot 931, according to the Survey of Eagle Point, 9th Sector, as recorded in Map Book 22, Page 102, in the Probate Office of Shelby County, Alabama.

Subject to Ad Valorem taxes for the year 1997 and subsequent years not yet due and payable.

Subject to covenants and restrictions, building lines, easements and rights of way of record.

Subject to Mineral and Mining rights of record and all rights and privileges incident thereto.

There is reserved a 35' "Green Belt Area" along any lot line that is adjacent to the golf course in which no structure nor fencing shall be placed, erected or maintained. There is further reserve a right of ingress and egress for all golfers to retrieve golf balls from the property.

TO HAVE AND TO HOLD, To the said Grantee, his, her or their heirs and assigns forever.




