KNOW ALL MEN BY THESE PRESENTS, That in consideration of ONE HUNDRED THIRTY-TWO THOUSAND FOUR HUNDRED SEVENTY-FIVE DOLLARS AND NO/100's DOLLARS (\$132,475.00) to the undersigned grantor, CORNERSTONE BUILDING COMPANY, INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto BRADLEY K. YODER and TROYA R. YODER (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:
