The limited liability company shall have two managers who shall serve until the first annual meeting or until their successor are elected and qualified. The initial two managers shall be:

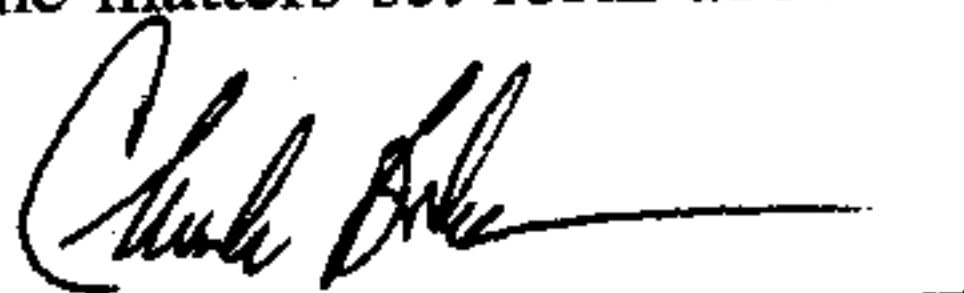

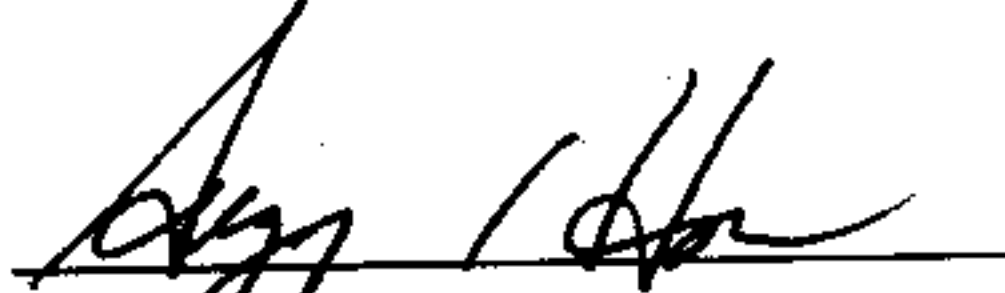
ARTICLE ELEVEN
