KNOW ALL MEN BY THESE PRESENTS, That in consideration of **TWO HUNDRED SEVENTY-FOUR THOUSAND EIGHT HUNDRED TWENTY-FIVE DOLLARS AND NO/100's (\$274,825.00)** to the undersigned grantor, **ROBERT S. GRANT CONST., INC.**, a corporation, (herein referred to as **GRANTOR**), in hand paid by the **GRANTEES** herein, the receipt of whereof is acknowledged, the said **GRANTOR** does by these presents grant, bargain, sell, and convey unto **DAVID J. DELK and DEBORAH F. DELK** (herein referred to as **GRANTEES**) as joint tenants, with right of survivorship, the following described real estate, situated in **SHELBY County, Alabama**:

Lot 751, according to the Map of Highland Lakes, 7th Sector, an Eddleman Community, as recorded in Map Book 20, Page 58 A, B & C, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.
